The U.S. federal government taxes personal income using a graduated or progressive scale. Tax rates began at 10% in 2014 and gradually increased to 15%, then 25%, 28%, 33%, 35%, and finally a top rate of 39.6%. Each tax rate applies to a specific range of income called a tax bracket.
