Washington food stamps provide enrolled families that are struggling financially with the funds they need to buy healthy groceries. Also called the Supplemental Nutrition Assistance Program (SNAP), beneficiaries enrolled in SNAP in Washington are awarded monetary allotments so they can go grocery shopping.

Basic Food is a food and nutrition program for individuals & families who meet the income guideline (listed at right) afford healthier foods by providing monthly benefits to buy food. Basic Food will also qualify you for Free or Reduced School Meals for your child.

2019-2020 WIC Income Eligibility Standards

The Washington Basic Food program (Basic Food) is a federally funded nutrition program to help low-income individuals and families buy food. This rule is a summary of the rules for Basic Food. (1) When you apply for Basic Food, we decide who is in your assistance unit (AU) based on the requirements under WAC 388-408-0034 and 388-408-0035 .

WIC Eligibility. Eligibility depends on household size and income. WIC is a nutrition program for pregnant women, new and breastfeeding moms, and children under five. Dad, grandparents, and other caregivers of children under the age of five may also sign kids up for WIC.

Eligibility for Washington Food Stamps The food stamps requirements in Washington reflect similar requirements nationwide under the federal food stamps program. Food stamps eligibility is primarily based upon your total household income, with several other factors that also contribute to your overall eligibility.

DSHS calculates the number of required monthly hours by dividing your food benefits amount by the local minimum wage. Call DSHS to get the exact number of hours you must do. Take part in Basic Food Employment and Training (BFET). Take part in Resources to Initiate Successful Employment (RISE).

(1) If your assistance unit (AU) meets all other eligibility requirements for basic food, your AU must have income at or below the limits in columns B and C of this subsection to get basic food, unless you meet one of the exceptions listed below in subsection (2) of this section.

(1) We do not count the following types of income when we determine your cash assistance and basic food benefits: (a) Bona fide loans as defined in WAC 388-470-0045 , except certain student loans as specified under WAC 388-450-0035 ;

### [WAC 388-400-0040: - Washington](#)

Eligibility for DSHS Basic Food Assistance generally follows the income guidelines listed below: Right click a table cell to select deletion of a row or column in order to size the table according to your needs.

### [WAC 388-414-0001: - Washington](#)

For most SNAP applicants, eligibility depends on income falling beneath a gross and net limit. These limits change annually, based on cost-of-living adjustments. However, for disabled veterans or their surviving spouses, the gross income limits do not apply as long as they receive either disability payments or funding for an aide or attendant for the disabled individual.

### [Do I qualify? | DSHS](#)

Basic Food households must report when their income goes over 130 percent of the income poverty levels based on the number of eligible household members in their assistance unit. A household meets reporting requirements under simplified reporting when the household reports their income is above 130 percent of the income poverty level, but they remain eligible for Basic Food.

### Reporting Requirements | DSHS

Receives income once a month. Annual: Total income for 1 year. 1. If a household has only one source of income, or if all the sources are paid at the same interval, compare the income to the same interval of the WIC income guidelines for the household size. 2. If a household has income sources at more than one interval, annualize all income and

### Learn about Basic Food (Food Stamps) and apply online ...

Each DSHS program has its own eligibility requirements; this is only a general overview. All programs consider your income. Some programs also consider your resources. Some programs are for those who are disabled, elderly or have minor children. Below is a table that outlines some of these requirements:

### WAC 388-450-0015: - Washington

(a) Being categorically eligible (CE) means that you have already met requirements for the program. If you are CE, you do not have to meet every program requirement to be eligible for basic food.
